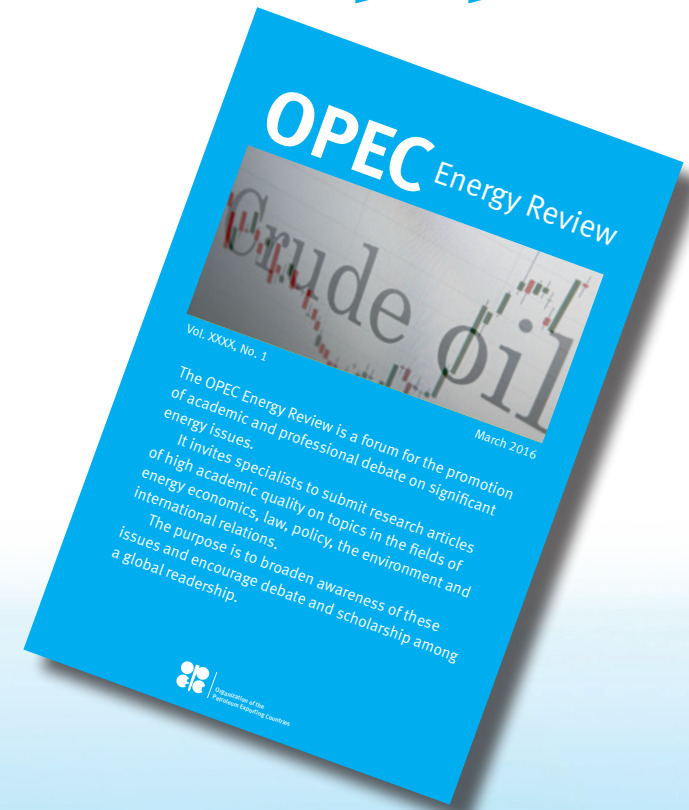
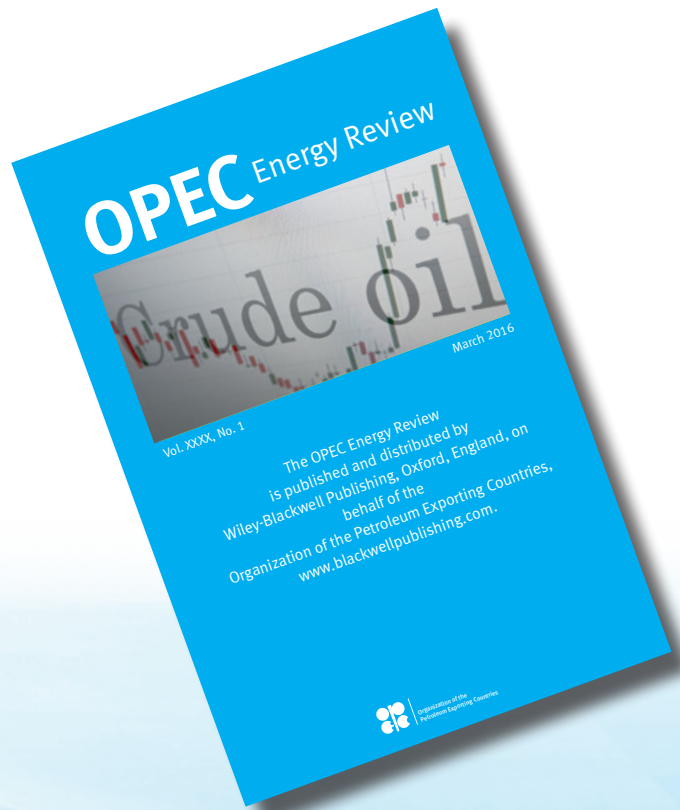

We invite you to submit a well researched scholarly paper for publication in OPEC's relaunched quarterly academic journal, the **OPEC Energy Review**, which specialises in the fields of energy economics, law, policy, the environment and international relations.

The **OPEC Energy Review** succeeds the OPEC Review after more than 30 years of publication, during which time it established itself as a respected scholarly publication, distributed to universities, research institutes and other centres of learning across the world.

Abstracts of up to 150 words should be included. In the covering letter, or on a separate sheet, the following details of the principal author should be given: full name (and, if different, desired name for publication purposes), title, affiliation, full postal address, e-mail address and telephone numbers. Similar details should be provided for all co-authors, although they need not include telephone numbers.

Authors will retain copyright to their papers, while giving the Publishers’ Exclusive Licence to publish. To assist authors, an appropriate Exclusive Licence Form will be supplied to them by the OPEC Secretariat.

Manuscripts should be written in clear English and not exceed 8,000 words. Submissions should be done electronically, either via email attachment or compact disc (CD). Tables and figures should carry titles, relate directly to the text and be easily comprehensible. Mathematical expressions should be clearly presented, with equations numbered.

Endnotes should be indicated in the text consecutively, with superscript numbers, and should be explained in a list at the end of the text. Reference citations in the text should be by last name(s) of author(s) and date (for joint authorship of three or more names, the words “*et al*” should be inserted after the first name); references should be spelt out and listed in alphabetical order at the end of the paper (after the endnote listings). For more details of style, please refer to a recent issue of the **OPEC Energy Review**.

Fifteen free offprints of each published paper, as well as one complimentary copy per author of the issue containing the paper, will be sent to principal authors (or, where specified and with numbers adjusted accordingly, to individual authors of joint papers).

The **OPEC Energy Review** is a quarterly journal prepared by the OPEC Secretariat in Vienna. Each issue consists of a selection of original research papers on energy economics, law, policy, the environment and international relations. The principal objective of the **OPEC Energy Review** is to broaden awareness of these issues, enhancing scholarship in universities, research institutes and other centres of learning. The scope is international.

The criteria for publication in the **OPEC Energy Review** are that the material is the product of research in an area of interest and value to the readership, and that it is presented in an objective and balanced manner. Submission of a paper will be held to imply that it contains original, unpublished work and is not being submitted for publication elsewhere. Manuscripts are evaluated by referees.
